KEY EVENTS

SpeechieBites

SpeechieBites is a student-focused initiative with the mission of connecting speech therapy students and practising speech therapists. Clinicians are invited to share about their working experiences and areas of specialisation. In 2023, SpeechieBites hosted 4 events (2 in-person and 2 online), focusing on fluency, communication, voice, and swallowing and feeding. The events were well-attended and feedback was positive.

2. Speech Therapy Day (ST day)

ST day was held on 17 November 2023 as an in-person event with dinner provided. The highlight was a fireside chat with Dr Elizabeth Teh, Chithra Kathiresan and Yee Kaisin on the development of Singapore's speech therapy scene across the years, dealing with burnout and compassion fatigue, and their thoughts for the future. There were 53 attendees and feedback was positive.

3. Hanen collaboration


SALTS collaborated with Hanen to launch their first More Than Words workshop in a local time zone from 23-25 November 2023. Priority registration was given through SALTS.

4. Invoices and payments

All invoices from membership payments to advertisements are now generated through SALTS's new website platform, allowing for a more consolidated tracking of payments made and received. Digital payments through PayNow are now accepted along with more traditional forms of payments like direct bank transfers and PayPal.

SALTS has a total of 120 members as of 29 February 2024; a net increase since March 2023.

There has been a decrease in practising memberships, likely attributed to the cessation of in-person Hanen courses (historically the biggest membership draw) since the pandemic.

There has been an increase in student and associate memberships, likely attributed to regular SpeechieBites events that are targeted at students and individuals interested in the field of speech therapy.

There has also been an increase in overseas memberships, likely attributed to an increase in online forms of engagement since the pandemic.


WEBSITE STATISTICS

In general, SALTS has maintained its presence on Facebook, and has grown its presence on Instagram. Use of the SALTS X account has stagnated, consistent with global and local trends away from the use of X as a social media platform [2].




Figure 2: Facebook and Instagram visits






Figure 3: Demographics of Facebook and Instagram followers

The SALTS Facebook page and Instagram account are generally used to disseminate information (e.g., events, advertisements). Both have increased in reach and visits from the period of March 2023 to February 2024 (refer to figures 1 and 2 on the next page). 80-90% of followers are female and between 25-54 years of age on Facebook and 18-44 years of age on Instagram (figure 3).

Figure 1: Facebook and Instagram reach

FINANCIAL STATEMENTS


2023 saw a net increase in revenue and expenses as operations and in-person events resumed and/or increased after the pandemic. Although there was a slight deficit overall, financial standings were largely maintained. Rebates from the Hanen workshop was also directly transferred to members resulting in a decrease in overall revenue.



The net increase in revenue is primarily attributed to other income sources like job and event advertisements. There was a net decrease in membership fees as existing memberships were extended complimentary to ease the transition to SALTS's new web platform in September 2022.



The net increase in expenses is attributed to a range of factors such as workshops and seminars (e.g., in-person SpeechieBites events), software (e.g., Notion, Zoom), ST day^[3], training and honorariums for committee members, and salaries for administrative staff. The net gain in income tax in 2022 was because it was incorrectly calculated in 2021.
